MARKET VENDOR RULES & GUIDELINES

- Market Vendor Applications, non-refundable registration fee and any supporting documentation must be submitted by September 16th. Salt River Fields and Affordable Food Festivals are not responsible for applications that do not include the necessary documentation.
- Submission of an application does not guarantee acceptance for the event. Due to the limited space, vendor selection will be based on products/services, completion of paperwork, and payment. Salt River Fields & Affordable Food Festivals staff reserves the right to limit the number of Market Vendors in all categories. Application fees will be refunded to any vendor not approved.
- All vendors must hold a current SRPMIC business license if selling items onsite. Please contact Juana Fulwilder at (480)-362-7649 or email juana.fulwilder@srpmic-nsn.gov.

BOOTH REQUIREMENTS

- Exclusivity is NOT guaranteed to ANY participant.
- Booth space is NOT reserved until payment is received.
- Booth spaces are randomly assigned. Vendor locations are non- negotiable.
- Vendors are responsible for setup and teardown of all signage, tents, tables, and equipment (except furnishings by SRF).
- You may use only your assigned space.
- Vehicles are only allowed on the event site for setup prior to the event and for teardown after the event closes. You will be notified when it is safe to bring your vehicle onto the event site. All vendors will receive a confirmation letter regarding load-in and load-out times.
- In an effort to protect your space and effectively maintain cleanliness, of the event, any vendor not staffing their booth for the duration of the event will be required to "close their booth". Vendors not adhering to this policy will be fined \$75.

LOAD-IN/LOAD-OUT INFORMATION

- Vendors may load in on Friday, October 14th from 9am to 6pm and Saturday, October 15th from 6am to 9am
- All vendors must be in place by 10am on October 15th and ready by 11am.
- Load-out for the event can begin after 7pm on Sunday, October 16th or upon approval from Salt River Fields staff.
